4a (Code:) (Expenses \$ 2,700,913. including grants of \$) (Revenue \$) NORTH CAROLINA WAS SEVERELY IMPACTED BY HURRICANE HELENE PRIMARILY IN ITS WESTERN APPALACHIAN REGION, CAUSING OVER 100 STORM-RELATED DEATHS IN THE STATE ALONE AND SIGNIFICANT DESTRUCTION OF INFRASTRUCTURE AND RESIDENTIAL AREAS ACROSS SEVERAL SETTLEMENTS. AFTER MAKING LANDFALL IN THE BIG BEND REGION OF FLORIDA ON SEPTEMBER 26TH, THE HURRICANE BEGAN TO TRAVERSE OVER LAND ACROSS GEORGIA AS A CATEGORY 2 HURRICANE AND INTO THE APPALACHIAN MOUNTAIN RANGE AS A TROPICAL STORM, DEPOSITING RECORD-BREAKING AMOUNTS OF RAINFALL ACROSS SEVERAL SETTLEMENTS IN WESTERN NORTH CAROLINA, SUCH AS ASHEVILLE, SWANNANOVA, CHIMNEY ROCK, MONTREAT, LAKE LURE, AND SEVERAL OTHERS.

AS A RESULT OF THE HISTORIC RAINFALL, SEVERAL RIVERS IN THE REGION 4b (Code:) (Expenses \$ 2,364,662. including grants of \$) (Revenue \$) ON SEPTEMBER 26, 2024, HURRICANE HELENE MADE LANDFALL AS A CATEGORY 4 HURRICANE, FOLLOWED BY HURRICANE MILTON ON OCTOBER 9TH, 2024, A CATEGORY 3 HURRICANE IN PASCO COUNTY, FLORIDA. HURRICANE MILTON AFFECTED 35 COUNTIES AS IT MOVED ACROSS FLORIDA, SPARKING 19 TORNADOES ACROSS THE STATE. TWO BACK-TO-BACK HURRICANES EXACERBATED IMPACTS DUE TO ALREADY FLOODED AREAS AND EXISTING DEBRIS THAT WAS YET TO BE CLEARED, IN ADDITION TO THE EMOTIONAL AND PSYCHOLOGICAL TRAUMA FOR RESIDENTS. COMBINED ESTIMATED COST OF THE STORMS IN DAMAGES IS IN THE TENS OF BILLIONS OF USD.

OUR GOAL IS TO SUPPORT LONG-TERM RECOVERY EFFORTS FOR COMMUNITIES IN PASCO COUNTY AFFECTED BY HURRICANE HELENE AND MILTON BY REPAIRING 4c (Code:) (Expenses \$ 1,363,557. including grants of \$) (Revenue \$) ON JANUARY 7TH TWO LARGE WILDFIRES ERUPTED IN THE PALISADES AND EATON, WHICH THEN SPREAD VERY QUICKLY OVER THE FOLLOWING WEEK AND WERE AMONG THE MOST DESTRUCTIVE OF HUMAN PROPERTY IN THE HISTORY OF SOUTHERN CALIFORNIA. THE 2025 LOS ANGELES WILDFIRES CLAIMED THE LIVES OF AT LEAST 28 PEOPLE, CHARRED OVER 45,000 ACRES OF LAND, AND DIRECTLY IMPACTED 1.2 MILLION PEOPLE. OVER 17,000 STRUCTURES ARE REPORTED TO HAVE BEEN DESTROYED BY THE PALISADES, EATON, AND HUGHES FIRES COMBINED. MORE THAN 130,000 PERSONS EVACUATED FROM AFFECTED AREAS AND ARE UNCERTAIN ABOUT RETURNING TO THEIR COMMUNITIES.
